The **German American Chamber of Commerce** and the **German Mission** to the UN organize a UN Procurement Seminar exclusively for German companies for the **5th time** at the German Mission in New York, centrally located across the street from the **UN Headquarters**.

This seminar provides the unique possibility for **one-on-one meetings** with UN Procurement staff.

Doing business with the United Nations offers great potential. In 2016, UN organizations procured for a total of USD **17.7 billion** in goods (49.2%) and services (50.8%) for peacekeeping,

humanitarian, and development projects around the world.

This seminar will concentrate on procurement from UN organizations based in New York: **UNPD, UNDP, UNICEF, UNOPS, and UNFPA**.

The main focus will be on **ICT, safety & security, water, energy, and shelter and accomodation solutions**.

Procurement and technical staff from **each organization will be present**, and as a special service, staff will be available for **one-on-one meetings** during the event.

UNPD is the biggest UN organization and has the largest share in the procurement volume (USD 3.2 billion in 2016) as well as the broadest supplier base. UNPD is specialized in procurement of goods and services in the areas mentioned above, e.g. ICT: USD 126 million / Safety & Security: USD 28.6 million. Together with the **DFS** they will be participating in panel discussions and will present the unique opportunity for one-on-one meetings. DFS provides support to peacekeeping field missions and political field missions, crucial in setting requirements.

UNDP works in almost 170 countries with a total procurement volume of USD 1.7 billion in 2016 and carries out part of their procurement activities through their country offices. Procurement of goods and services in ICT was USD 88.6 million in 2016 and USD 5.9 million were spent in the area of safety & security.

UNICEF has its supply division in Copenhagen, but IT procurement is done via the headquarters in New York (ICT procurement in 2016: USD 50 million).
